CONTINUITY AND ESTIMATES FOR MULTIMARGINAL OPTIMAL TRANSPORTATION PROBLEMS WITH SINGULAR COSTS

GIUSEPPE BUTTAZZO, THIERRY CHAMPION, AND LUIGI DE PASCALE

ABSTRACT. We consider some repulsive multimarginal optimal transportation problems which include, as a particular case, the Coulomb cost. We prove a regularity property of the minimizers (optimal transportation plan) from which we deduce existence and some basic regularity of a maximizer for the dual problem (Kantorovich potential). This is then applied to obtain some estimates of the cost and to the study of continuity properties.

1. INTRODUCTION

This paper deals with the following variational problem. Let $\rho \in \mathcal{P}(\mathbb{R}^d)$ be a probability measure, let $N > 1$ be an integer and let

$$c(x_1, \dots, x_N) = \sum_{1 \leq i < j \leq N} \phi(|x_i - x_j|),$$

with $\phi : (0, +\infty) \rightarrow \mathbb{R}$ satisfying the assumptions which will be described in the next section; in particular for $\phi(t) = 1/t$ we have the usual Coulomb repulsive cost. Consider the set of probabilities on \mathbb{R}^{Nd}

$$\Pi(\rho) = \{P \in \mathcal{P}(\mathbb{R}^{dN}) : \pi_{\sharp}^i P = \rho \text{ for all } i\},$$

where π^i denotes the projection on the i -th copy of \mathbb{R}^d and $\pi_{\sharp}^i P$ is the push-forward measure. We aim to minimize the total transportation cost

$$C(\rho) = \min_{P \in \Pi(\rho)} \int_{\mathbb{R}^{Nd}} c(x_1, \dots, x_N) dP(x_1, \dots, x_N). \quad (1.1)$$

This problem is called a multimarginal optimal transportation problem and elements of $\Pi(\rho)$ are called transportation plans for ρ . Some general results about multimarginal optimal transportation problems are available in [3, 17, 21, 22, 23]. Results for particular cost functions are available, for example in [11] for the quadratic cost, with some generalization in [15], and in [4] for the determinant cost function.

Optimization problems for the cost function $C(\rho)$ in (1.1) intervene in the so-called *Density Functional Theory* (DFT), we refer to [16, 18] for the basic theory of DFT and to [13, 14, 24, 25, 26] for recent development which are of interest for us. Some new applications are emerging for example in [12]. In the particular case of the Coulomb cost there are also many other open questions related to the applications. Recent results on the topic are contained in [2, 5, 6, 7, 10, 20] and some of them will

be better described in the subsequent sections. For more general repulsive costs we refer to the recent survey [9]. The literature quoted so far is not at all exhaustive and we refer the reader to the bibliographies of the cited papers for a more detailed picture.

Since the functions ϕ we consider are lower semicontinuous, the functional $\rho \mapsto C(\rho)$ above is naturally lower semicontinuous on the space of probability measures equipped with the tight convergence. In general it is not continuous as the following example shows. Take $N = 2$, $\phi(t) = t^{-s}$ for some $s > 0$, and

$$\rho = \frac{1}{2}\delta_x + \frac{1}{2}\delta_y, \quad \rho_n = \left(\frac{1}{2} + \frac{1}{n}\right)\delta_x + \left(\frac{1}{2} - \frac{1}{n}\right)\delta_y \quad \text{for } n \geq 1,$$

with $x \neq y$, which gives

$$C(\rho) = \frac{1}{|x - y|^s}, \quad C(\rho_n) = +\infty \quad \text{for } n \geq 1.$$

In the last section of the paper we show that the functional $C(\rho)$ is continuous or even Lipschitz on suitable subsets of $\mathcal{P}(\mathbb{R}^d)$ which are relevant for the applications.

Problem (1.1) admits the following Kantorovich dual formulation.

Theorem 1.1 (Proposition 2.6 in [17]). *The equality*

$$\min_{P \in \Pi(\rho)} \int_{\mathbb{R}^{Nd}} c(x_1, \dots, x_N) dP(x_1, \dots, x_N) = \sup_{u \in \mathcal{I}_\rho} \left\{ N \int u d\rho : \right. \\ \left. u(x_1) + \dots + u(x_N) \leq c(x_1, \dots, x_N) \right\} \quad (1.2)$$

holds, where \mathcal{I}_ρ denotes the set of ρ -integrable functions and the pointwise inequality is satisfied everywhere.

Thanks to the symmetries of the problem we also have that the right-hand side of (1.2) coincides with

$$\sup_{u_i \in \mathcal{I}_\rho} \left\{ \sum_{i=1}^N \int u_i d\rho : u_1(x_1) + \dots + u_N(x_N) \leq c(x_1, \dots, x_N) \right\}. \quad (1.3)$$

In fact, the supremum in (1.3) is a priori larger than the one in (1.2); however, since for any admissible N -tuple (u_1, \dots, u_N) the function

$$u(x) = \frac{1}{N} \sum_{i=1}^N u_i(x)$$

is admissible in (1.2), equality holds.

Definition 1.2. A function u will be called a Kantorovich potential if it is a maximizer for the right-hand-side of (1.2).

The paper [17] contains a general approach to the duality theory for multimarginal optimal transportation problems. A different approach which make use of a weaker definition of the dual problem (two marginals case) is introduced in [1] and may be applied to this situation too [2]. Existence of Kantorovich potentials is the topic of Theorem 2.21 of [17]. That theorem requires that there exist $h_1, \dots, h_N \in L^1_\rho$ such that

$$c(x_1, \dots, x_N) \leq h_1(x_1) + \dots + h_N(x_N),$$

and so it does not apply to the costs we consider in this paper, as for example the costs of Coulomb type. For Coulomb type costs, the existence of a Kantorovich potential is proved in [8] under the additional assumption that ρ is absolutely continuous with respect to the Lebesgue measure in \mathbb{R}^d . As a consequence of our main estimate, here we extend the existence result to a larger class of probability measures ρ . We then use the Kantorovich potentials as a tool.

We adopt the notation $\mathbf{x} = (x_1, \dots, x_N) \in \mathbb{R}^{Nd}$ so that $x_i \in \mathbb{R}^d$ for each $i \in \{1, \dots, N\}$. Also, we denote the cost of a transport plan $P \in \Pi(\rho)$ by

$$\mathfrak{C}(P) := \int_{\mathbb{R}^{Nd}} c(x_1, \dots, x_N) dP(x_1, \dots, x_N).$$

Finally, for $\alpha > 0$ we may also introduce the natural truncation of the cost

$$c_\alpha(x_1, \dots, x_N) = \sum_{1 \leq i < j \leq N} \min \{ \phi(|x_i - x_j|), \phi(\alpha) \} = \sum_{1 \leq i < j \leq N} \phi_\alpha(|x_i - x_j|),$$

with the natural notation $\phi_\alpha(t) := \min \{ \phi(t), \phi(\alpha) \}$ and the corresponding transportation costs $C_\alpha(\rho)$ and $\mathfrak{C}_\alpha(P)$.

2. RESULTS

We assume that ϕ satisfies the following properties:

- (1) ϕ is continuous from $(0, +\infty)$ to $[0, +\infty)$.
- (2) $\lim_{t \rightarrow 0^+} \phi(t) = +\infty$;
- (3) ϕ is strictly decreasing;

Remark 2.1. A careful attention to the present work shows that all our results also hold when (3) is replaced by the weaker hypothesis :

$$(3') \quad \phi \text{ is bounded at } +\infty, \text{ that is } \sup\{|\phi(t)| : t \geq 1\} < +\infty;$$

Under this assumption, one has to replace ϕ and ϕ^{-1} in the statements respectively by $\Phi(t) = \sup\{\phi(s) : s \geq t\}$ and $\Phi^{-1}(t) = \inf\{s : \phi(s) = t\}$. For example in Theorem 2.4 the number α should be chosen lower than $\Phi^{-1}\left(\frac{N^2(N-1)}{2}\Phi(\beta)\right)$. Even if less general, we believe that the present form and stronger hypothesis (3) makes our approach and arguments more clear.

Definition 2.2. For every $\rho \in \mathcal{P}(\mathbb{R}^d)$ the measure of concentration of ρ at scale r is defined as

$$\mu_\rho(r) = \sup_{x \in \mathbb{R}^d} \rho(B(x, r)).$$

In particular, if $\rho \in L^1(\mathbb{R}^d)$ we have $\mu_\rho(r) = o(1)$ as $r \rightarrow 0$, and more generally

$$\rho \in L^p(\mathbb{R}^d) \implies \mu_\rho(r) = o(r^{d(p-1)/p}) \quad \text{as } r \rightarrow 0.$$

The main role of the measures of concentration is played in the following assumption.

Assumption (A): We say that ρ has small concentration with respect to N if

$$\lim_{r \rightarrow 0} \mu_\rho(r) < \frac{1}{N(N-1)^2}.$$

For $\alpha > 0$ we denote by

$$D_\alpha := \{ \mathbf{x} = (x_1, \dots, x_N) : |x_i - x_j| < \alpha \text{ for some } i \neq j \}$$

the open strip around the singular set where at least two of the x_i coincide. Finally, we denote by $\mathbb{R}^{d(N-1)} \otimes_i A$ the Cartesian product on N factors the i -th of which is A while all the others are copies of \mathbb{R}^d .

Lemma 2.3. *Assume that ρ satisfies assumption **(A)**. Let $\mathbf{x} := \mathbf{x}^1 \in \mathbb{R}^d$ and let β be such that*

$$\mu_\rho(\beta) < \frac{1}{N(N-1)^2}.$$

Then for every $P \in \Pi(\rho)$ there exist $\mathbf{x}^2, \dots, \mathbf{x}^N \in \text{spt } P$ such that

$$\beta < |x_j^i - x_\sigma^k| \quad \text{for all } j, \sigma \text{ whenever } k \neq i.^1 \quad (2.1)$$

Proof. By definition of marginals and by the choice of β we have

$$P(\mathbb{R}^{d(N-1)} \otimes_\alpha B(x_i^k, \beta)) < \frac{1}{N(N-1)^2}$$

for all indices α, i, k . Then for any $j \in \{2, \dots, N\}$

$$P\left(\bigcup_{k=1}^{j-1} \bigcup_{i=1}^N \bigcup_{\alpha \neq i} \mathbb{R}^{d(N-1)} \otimes_\alpha B(x_i^k, \beta)\right) < \frac{j-1}{N-1},$$

and, since P is a probability measure, this allows us to choose

$$\mathbf{x}^j \in \text{spt } P \setminus \left(\bigcup_{k=1}^{j-1} \bigcup_{i=1}^N \bigcup_{\alpha \neq i} \mathbb{R}^{d(N-1)} \otimes_\alpha B(x_i^k, \beta)\right).$$

It is easy to verify that the \mathbf{x}^j above satisfy the desired property (2.1). \square

2.1. Estimates for the optimal transport plans.

Theorem 2.4. *Let $\rho \in \mathcal{P}(\mathbb{R}^d)$ and assume that ρ satisfies assumption **(A)**. Let $P \in \Pi(\rho)$ be a minimizer for the transportation cost $C(\rho)$ (or $C_\alpha(\rho)$) and let β be such that*

$$\mu_\rho(\beta) < \frac{1}{N(N-1)^2}.$$

Then

$$\text{spt } P \subset \mathbb{R}^{Nd} \setminus D_\alpha \quad \text{whenever} \quad \alpha < \phi^{-1}\left(\frac{N^2(N-1)}{2}\phi(\beta)\right).$$

Proof. We make the proof for the case where P is a minimizer for $C(\rho)$, the argument being the same for $C_\alpha(\rho)$. Take α as in the statement and $\delta \in (0, \alpha)$. Note from the hypotheses on ϕ that $\alpha < \beta$. Assume that $\mathbf{x}^1 = (x_1^1, \dots, x_N^1) \in D_\delta \cap \text{spt } P$ and choose points $\mathbf{x}^2, \dots, \mathbf{x}^N$ in $\text{spt } P$ as in Lemma 2.3. Let k be large enough so that $\delta + 2\beta/k < \alpha$. Since all the chosen points belong to $\text{spt } P$, we have

$$P(Q(\mathbf{x}^i, \beta/k)) > 0$$

where $Q(\mathbf{x}^i, \beta/k) = \prod_{j=1}^N B(\mathbf{x}_j^i, \beta/k)$. Denote by $P_i = P|_{Q(\mathbf{x}^i, \frac{\beta}{k})}$ and choose constants $\lambda_i \in (0, 1]$ such that

$$\lambda_1 |P_1| = \dots = \lambda_N |P_N| := \varepsilon,$$

where $|P_i|$ denotes the mass of the measure P_i . We then write

$$P = \lambda_1 P_1 + \dots + \lambda_N P_N + P_R \quad (P_R \text{ is the remainder}),$$

and we estimate from below the cost of P as follows:

$$\mathfrak{C}(P) = \mathfrak{C}(P_R) + \sum_{i \geq 1} \mathfrak{C}(\lambda_i P_i) \geq \mathfrak{C}(P_R) + \varepsilon \phi(\alpha)$$

where we used the fact that $\mathbf{x}^1 \in D_\delta$ and $\delta + 2\beta/k < \alpha$. We consider now the marginals ν_1^i, \dots, ν_N^i of $\lambda_i P_i$ and build the new local plans

$$\tilde{P}_1 = \nu_1^1 \times \nu_2^2 \times \dots \times \nu_N^N, \quad \tilde{P}_2 = \nu_1^2 \times \nu_2^3 \times \dots \times \nu_N^1, \quad \dots, \quad \tilde{P}_N = \nu_1^N \times \nu_2^1 \times \dots \times \nu_N^{N-1}.$$

To write the estimates from above it is convenient to remark that we may also write

$$\tilde{P}_i = \nu_1^i \times \dots \times \nu_k^{i+k-1} \times \dots \times \nu_N^{i+N-1}$$

where we consider the upper index (mod N). Consider now the transport plan

$$\tilde{P} := P_R + \tilde{P}_1 + \dots + \tilde{P}_N;$$

it is straightforward to check that the marginals of \tilde{P} are the same as the marginals of P . Moreover $|\tilde{P}_i| = \lambda_i |P_i|$. So we can estimate the cost of \tilde{P} from above using the distance between the coordinates of the centers of the cubes established in Lemma 2.3, and we obtain

$$\mathfrak{C}(\tilde{P}) = \mathfrak{C}(P_R) + \sum_{i=1}^N \mathfrak{C}(\tilde{P}_i) \leq \mathfrak{C}(P_R) + N \frac{N(N-1)}{2} \phi(\beta - 2\beta/k) \varepsilon.$$

Then if

$$\alpha < \phi^{-1} \left(\frac{N^2(N-1)}{2} \phi(\beta - \frac{2\beta}{k}) \right)$$

we have that

$$\mathfrak{C}(\tilde{P}) < \mathfrak{C}(P),$$

thus contradicting the minimality of P . It follows that the strip D_{α_1} and $\text{spt } P$ do not intersect if α satisfies the inequality above and since k may be arbitrarily large and ϕ is continuous we obtain the conclusion for any $\alpha_1 \in (0, \alpha)$, which concludes the proof. \square

The Theorem above allow us to estimate the costs in term of β .

Proposition 2.5. *Let $\rho \in \mathcal{P}(\mathbb{R}^d)$ and assume that ρ satisfies assumption **(A)**. Then if β is such that*

$$\mu_\rho(\beta) < \frac{1}{N(N-1)^2}$$

we have

$$C(\rho) \leq \frac{N^3(N-1)^2}{4} \phi(\beta).$$

Moreover,

$$C(\rho) = C_\alpha(\rho) \quad \text{whenever} \quad \alpha \leq \phi^{-1} \left(\frac{N^2(N-1)}{2} \phi(\beta) \right).$$

Proof. Let P be an optimal transport plan for the cost C . According to Theorem 2.4, if α is as in the statement then the support of P may intersect only the boundary of D_α and this means that $c \leq \frac{N(N-1)}{2} \phi(\alpha)$ on the support of P . Then

$$C(\rho) \leq \int \frac{N(N-1)}{2} \phi(\alpha) dP = \frac{N(N-1)}{2} \phi(\alpha)$$

and, taking the largest admissible α we obtain

$$C(\rho) \leq \frac{N^3(N-1)^2}{4} \phi(\beta),$$

which is the desired estimate. Let now P_α be an optimal plan for the cost C_α , then also $\text{spt } P_\alpha \subset \mathbb{R}^{Nd} \setminus D_\alpha$ so that $c = c_\alpha$ on $\text{spt } P_\alpha$. It follows that

$$C(\rho) \leq \int c dP_\alpha = \int c_\alpha dP_\alpha = C_\alpha(\rho),$$

and since the opposite inequality is always true we conclude the proof. \square

As a consequence of Proposition 2.5 above, Proposition 2.6 of [17] and Theorem 2.21 of [17] we also obtain an extension of the duality theorem of [8] to a wider set of ρ .

Theorem 2.6. *Let $\rho \in \mathcal{P}(\mathbb{R}^d)$ and assume that ρ satisfies assumption **(A)**. Then*

$$C(\rho) = \max_{u \in \mathcal{I}_\rho} \left\{ N \int u d\rho : u(x_1) + \dots + u(x_N) \leq c(x_1, \dots, x_N) \right\}. \quad (2.2)$$

Moreover, whenever $\alpha \leq \phi^{-1}\left(\frac{N^2(N-1)}{2}\phi(\beta)\right)$, any Kantorovich potential u_α for C_α is also a Kantorovich potential for C .

Proof. By monotonicity of the integral the left-hand side of (2.2) is always larger than the right-hand side. Proposition 2.6 and Theorem 2.21 of [17] may be applied to the cost c_α to obtain

$$C_\alpha(\rho) = \max_{u \in \mathcal{I}_\rho} \left\{ N \int u d\rho : u(x_1) + \dots + u(x_N) \leq c_\alpha(x_1, \dots, x_N) \right\}.$$

Since ρ satisfies assumption **(A)**, by Proposition 2.5 for α sufficiently small we have that there exists $u_\alpha \in \mathcal{I}_\rho$ such that

$$u_\alpha(x_1) + \dots + u_\alpha(x_N) \leq c_\alpha(x_1, \dots, x_N) \leq c(x_1, \dots, x_N),$$

and

$$C(\rho) = C_\alpha(\rho) = N \int u_\alpha d\rho,$$

as required. \square

Remark 2.7. Note that if u is a Kantorovich potential for C and P is optimal for C then $u(x_1) + \dots + u(x_N) = c(x_1, \dots, x_N)$ holds P -almost everywhere.

3. APPLICATIONS

3.1. Estimates for the cost. Since the parameter β in the previous section is naturally related to the summability of ρ , we can obtain some estimate of the cost $C(\rho)$ in term of the available norms of ρ .

Proposition 3.1. *Let $\rho \in \mathcal{P}(\mathbb{R}^d) \cap L^p(\mathbb{R}^d)$ for some $p > 1$. Then, if $P \in \Pi(\rho)$ is optimal for the transportation cost $C(\rho)$, we have*

$$P(D_\alpha) = 0 \quad \text{whenever} \quad \alpha < \phi^{-1}\left(\frac{N^2(N-1)}{2}\phi\left(\left(\frac{1}{\omega_d(N(N-1)^2)^{p'}\|\rho\|_p^{p'}}\right)^{1/d}\right)\right),$$

where ω_d denotes the Lebesgue measure of the ball of radius 1 in \mathbb{R}^d and p' the conjugate exponent of p . It follows that

$$C(\rho) \leq \frac{N^3(N-1)^2}{4} \phi \left(\left(\frac{1}{\omega_d(N(N-1)^2)^{p'} \|\rho\|_p^{p'}} \right)^{1/d} \right). \quad (3.1)$$

Proof. Let

$$\beta \leq \left(\frac{1}{\omega_d(N(N-1)^2)^{p'} \|\rho\|_p^{p'}} \right)^{1/d}.$$

By Hölder inequality we have

$$\int_{B(x,\beta)} \rho(y) dy \leq \|\rho\|_p (\omega_d \beta^d)^{1/p'} \leq \frac{1}{N(N-1)^2},$$

so that

$$\mu_\rho(\beta) \leq \frac{1}{N(N-1)^2}.$$

The desired inequality (3.1) now follows by Theorem 2.5. \square

Remark 3.2. The Coulomb type costs $\phi(t) = t^{-s}$ for $s > 0$ play a relevant role in several applications.

(1) For $\phi(t) = t^{-s}$ estimate (3.1) above takes the form

$$C(\rho) \leq \frac{N^3(N-1)^2}{4} \left(\omega_d(N(N-1)^2)^{p'} \|\rho\|_p^{p'} \right)^{s/d}.$$

(2) In dimension $d = 3$ and for $s = 1$ the set

$$\mathcal{H} := \left\{ \rho \in L^1(\mathbb{R}^3) : \rho \geq 0, \sqrt{\rho} \in H^1(\mathbb{R}^3), \int \rho dx = 1 \right\}$$

plays an important role in the Density Functionals Theory. In fact, Lieb in [19] proved that $\rho \in \mathcal{H}$ if and only if there exists a wave function $\psi \in H^1(\mathbb{R}^{3N})$ such that

$$\pi_{\#}^i |\psi|^2 dx = \rho, \quad \text{for } i = 1, \dots, N.$$

Taking $s = 1$, $d = 3$, $p = 3$ in Proposition 3.1 gives

$$C(\rho) \leq CN^{7/2}(N-1)^3 \|\rho\|_3^{1/2} = CN^{7/2}(N-1)^3 \|\sqrt{\rho}\|_6 \leq CN^{7/2}(N-1)^3 \|\sqrt{\rho}\|_{H^1}.$$

3.2. Estimates for Kantorovich potentials. In general, a Kantorovich potential u is a ρ -integrable function which can be more or less freely modified outside a relevant set. In this section we show the existence of Kantorovich potentials which are more regular.

Lemma 3.3. *Let u be a Kantorovich potential; then there exists a Kantorovich potential \tilde{u} which satisfies*

$$u \leq \tilde{u},$$

and

$$\tilde{u}(x) = \inf \left\{ c(x, y_2, \dots, y_N) - \sum_{j=2}^N \tilde{u}(y_j) : y_j \in \mathbb{R}^d \right\} \quad \forall x \in \mathbb{R}^d. \quad (3.2)$$

Proof. We first define

$$\bar{u}(x) := \inf \left\{ c(x, y_2, \dots, y_N) - \sum_{j \geq 2} u(y_j) : y_j \in \mathbb{R}^d \right\};$$

then we consider

$$\hat{u}(x) = \frac{\bar{u}(x) + (N-1)u(x)}{N}.$$

Since $u(x) \leq \bar{u}(x)$ we have also $u(x) \leq \hat{u}(x)$; moreover it is straightforward to check that

$$\hat{u}(x_1) + \dots + \hat{u}(x_N) \leq c(x_1, \dots, x_N) \quad \forall x_i \in \mathbb{R}^d.$$

Notice that if u does not satisfy (3.2) at some x then $u(x) < \hat{u}(x)$. We then consider

$$\tilde{u}(x) = \sup \left\{ v(x) : u \leq v \text{ } \rho\text{-a.e. and } v(x_1) + \dots + v(x_N) \leq c(x_1, \dots, x_N) \right\}$$

which satisfies all the required properties (since $\tilde{u} = \hat{u}$). \square

Taking some constant $\alpha_1, \dots, \alpha_N$ such that $\sum \alpha_i = 0$ we may define $u_i(x) = \tilde{u}(x) + \alpha_i$ and we obtain an N -tuple of functions which is optimal for problem (1.3) and satisfies

$$u_i(x) = \inf \left\{ c(y_1, \dots, y_{i-1}, x, y_{i-1}, \dots, y_N) - \sum_{j \neq i} u_j(y_j) : y_j \in \mathbb{R}^d \right\}.$$

The choice of the constants α_i can be made so that the functions u_i take specific and admissible values at some points. A final, elementary, remark is that \tilde{u} is the arithmetic mean of the u_i s.

Theorem 3.4. *Let $\rho \in \mathcal{P}(\mathbb{R}^d)$. Assume that ρ satisfies assumption **(A)**, and let β be such that $\mu_\rho(\beta) \leq \frac{1}{N(N-1)^2}$. Let u be a Kantorovich potential which satisfies*

$$u(x) = \inf \left\{ c(x, \dots, y_2, \dots, y_N) - \sum_{j \geq 2} u(y_j) : y_j \in \mathbb{R}^d \right\}.$$

Then for any choice of α as in Theorem 2.4 it holds

$$\sup_{\mathbb{R}^d} |u| \leq N(N-1)^2 \phi\left(\frac{\alpha}{2}\right). \quad (3.3)$$

Proof. Let P be an optimal transport plan for C , let α be as in Theorem 2.4 and take $\bar{\mathbf{x}} \in \text{spt } P$, then $|\bar{\mathbf{x}}_i - \bar{\mathbf{x}}_j| \geq \alpha$ for $i \neq j$. From Remark 2.7 we can assume that $u(\bar{\mathbf{x}}_1) + \dots + u(\bar{\mathbf{x}}_N) = c(\bar{\mathbf{x}}_1, \dots, \bar{\mathbf{x}}_N)$. From the above discussion we may consider a Kantorovich N -tuple (u_1, \dots, u_N) obtained from u which is optimal for (1.3) and satisfies

$$u_i(x) = \inf \left\{ c(y_1, \dots, y_{i-1}, x, y_{i-1}, \dots, y_N) - \sum_{j \neq i} u_j(y_j) : y_j \in \mathbb{R}^d \right\} \quad \text{for all } x$$

and $u_i(\bar{\mathbf{x}}_i) = \frac{1}{N} c(\bar{\mathbf{x}}_1, \dots, \bar{\mathbf{x}}_N) \geq 0$ for all i . If $x \notin \cup_{i=2}^N B(\bar{\mathbf{x}}_i, \frac{\alpha}{2})$ it holds:

$$u_1(x) \leq c(x, \bar{\mathbf{x}}_2, \dots, \bar{\mathbf{x}}_N) - \sum_{j \geq 2} u_j(\bar{\mathbf{x}}_j) \leq c(x, \bar{\mathbf{x}}_2, \dots, \bar{\mathbf{x}}_N) \leq \frac{N(N-1)}{2} \phi\left(\frac{\alpha}{2}\right).$$

Taking $\mathbf{x}^1 = \bar{\mathbf{x}}$, we apply Lemma 2.3 and obtain a point $\mathbf{x}^2 \in \text{spt } P \setminus D_\alpha$ such that $|\mathbf{x}_j^2 - \bar{\mathbf{x}}_\sigma| \geq \beta \geq \alpha$ for all j and σ , and from Remark 2.7 we may assume that

$$-\sum_{j=2}^N u_j(\mathbf{x}_j^2) = u_1(\mathbf{x}_1^2) - c(\mathbf{x}_1^2, \dots, \mathbf{x}_N^2) \leq u_1(\mathbf{x}_i^2) \leq \frac{N(N-1)}{2} \phi\left(\frac{\alpha}{2}\right)$$

where we used $\mathbf{x}_1^2 \notin \cup_{j \geq 2} B(\bar{\mathbf{x}}_j, \alpha)$. Fix $i \geq 2$, it follows that if $x \in B(\bar{\mathbf{x}}_i, \frac{\alpha}{2})$ then $|x - \mathbf{x}_j^2| \geq \frac{\alpha}{2}$ for all $j \geq 2$ so that

$$u_1(x) \leq c(x, \mathbf{x}_2^2, \dots, \mathbf{x}_N^2) - \sum_{j=2}^N u_j(\mathbf{x}_j^2) \leq N(N-1) \phi\left(\frac{\alpha}{2}\right)$$

This concludes the estimate from above for u_1 on \mathbb{R}^d , and analogously for all u_i . The formula above now allows us to find an estimate from below which, again, we write for u_1 as

$$u_1(x) = \inf \left\{ c(x, y_2, \dots, y_N) - \sum_{j=2}^N u_j(y_j) : y_j \in \mathbb{R}^d \right\} \geq -N(N-1)^2 \phi\left(\frac{\alpha}{2}\right).$$

Then for all i one has

$$\|u_i\|_\infty \leq N(N-1)^2 \phi\left(\frac{\alpha}{2}\right),$$

and analogously for $u = \frac{1}{N} \sum_i u_i$ the same estimate holds. \square

Remark 3.5. Theorem 3.4 above applies to all costs considered in this paper including c_α obtained replacing the function ϕ by its truncation ϕ_α .

The next theorem shows that under the usual assumptions on ρ and some additional assumptions on ϕ there exists a Kantorovich potential which is Lipschitz and semiconcave with Lipschitz and semiconcavity constants depending on the concentration of ρ . In the next statement we denote by $Sc(u)$ the semiconcavity constant, that is the lowest nonnegative constant K such that $u - K|\cdot|^2$ is concave.

Theorem 3.6. *Let $\rho \in \mathcal{P}(\mathbb{R}^d)$. Assume that ρ satisfies assumption **(A)**, and let β be such that $\mu_\rho(\beta) \leq \frac{1}{N(N-1)^2}$.*

- If ϕ is of class \mathcal{C}^1 and for all $t > 0$ there exists a constant $\mathcal{L}(t)$ such that

$$|\phi'(s)| < \mathcal{L}(t) \quad \text{for all } s > t \quad (3.4)$$

then there exists a Kantorovich potential u for problem (1.2) such that

$$\text{Lip}(u) \leq \mathcal{L} \left(\phi^{-1} \left(\frac{N^2(N-1)}{2} \phi(\beta) \right) \right).$$

- If ϕ is of class \mathcal{C}^2 and for all $t > 0$ there exists a constant $\mathcal{K}(t)$ such that

$$\phi''(s) - \frac{\phi'(s)}{s} < \mathcal{K}(t) \quad \text{for all } s > t$$

then there exists a Kantorovich potential u for problem (1.2) such that

$$Sc(u) \leq \mathcal{K} \left(\phi^{-1} \left(\frac{N^2(N-1)}{2} \phi(\beta) \right) \right).$$

Proof. According to Proposition 2.5 and Theorem 2.6 for $\alpha \leq \phi^{-1}\left(\frac{N^2(N-1)}{2}\phi(\beta)\right)$ any Kantorovich potential u_α for the cost \mathfrak{C}_α is also a potential for \mathfrak{C} . According to Lemma 3.3 above we choose a potential u_α satisfying

$$\forall x, \quad u_\alpha(x) = \inf \left\{ c_\alpha(x, \dots, y_2, \dots, y_N) - \sum_{j \geq 2} u(y_j) : y_j \in \mathbb{R}^d \right\}.$$

Since the infimum of uniformly Lipschitz (resp. uniformly semiconcave) functions is still Lipschitz (resp. semiconcave) with the same constant, it is enough to show that the functions

$$x \mapsto c_\alpha(x, \dots, y_2, \dots, y_N) + C$$

are uniformly Lipschitz and semiconcave. To check that it is enough to compute the gradient and the Hessian matrix of these functions and use the respective properties of the pointwise cost ϕ . \square

Remark 3.7. The above Theorem 3.6 applies to the Coulomb cost $\phi(t) = 1/t$ and more generally to the costs $\phi(t) = t^{-s}$ for $s > 0$.

3.3. Continuity properties of the cost. In this subsection we study some conditions that imply the continuity of the transportation cost $C(\rho)$ with respect to the tight convergence on the marginal variable ρ .

Lemma 3.8. *Let $\{\rho_n\} \subset \mathcal{P}(\mathbb{R}^3)$ be such that $\rho_n \xrightarrow{*} \rho$ and assume that ρ satisfies assumption (A). Let β be such that*

$$\mu_\rho(\beta) < \frac{1}{N(N-1)^2}.$$

Then for all $\delta \in (0, 1)$ there exists $k \in \mathbb{N}$ such that for all $n > k$

$$\mu_{\rho_n}(\delta\beta) < \frac{1}{N(N-1)^2}.$$

Proof. We argue by contradiction assuming that there exists a sequence $\{x_n\}$ such that

$$\frac{1}{N(N-1)^2} \leq \rho_n(B(x_n, \delta\beta)).$$

Since the sequence $\{\rho_n\}$ is uniformly tight there exists K such that $|x_n| < K$. Up to subsequences we may assume that $x_n \rightarrow \tilde{x}$ for a suitable \tilde{x} . Let $\delta' \in (\delta, 1)$. Then, for n large enough, $\overline{B(x_n, \delta\beta)} \subset B(\tilde{x}, \delta'\beta)$ and since

$$\rho_n(B(x_n, \delta\beta)) \leq \rho_n(\overline{B(x_n, \delta\beta)}) \leq \rho_n(\overline{B(x, \delta'\beta)}),$$

and

$$\limsup \rho_n(\overline{B(x, \delta'\beta)}) \leq \rho(\overline{B(x, \delta'\beta)}) \leq \rho(B(x, \beta))$$

we obtain

$$\limsup \rho_n(B(x, \delta\beta)) < \frac{1}{N(N-1)^2},$$

which is a contradiction. \square

Theorem 3.9. *Let $\{\rho_n\} \subset \mathcal{P}(\mathbb{R}^3)$ be such that $\rho_n \xrightarrow{*} \rho$ with ρ satisfying assumption (A). Assume that the cost function ϕ satisfies assumption (3.4). Then*

$$C(\rho_n) \rightarrow C(\rho) \quad \text{as } n \rightarrow +\infty.$$

Proof. We first note that the theorem above holds for the costs c_α since they are continuous and bounded in \mathbb{R}^d , and from the fact that whenever $P \in \Pi(\rho)$ there exists $P_n \in \Pi(\rho_n)$ such that $P_n \xrightarrow{*} P$, so that C_α is continuous with respect to weak convergence.

Thanks to Lemma 3.8 and Theorem 2.4 we infer that there exists $k > 0$ and $\alpha > 0$ such that the optimal transport plans for $C(\rho)$ and $C(\rho_n)$ are all supported in $\mathbb{R}^{N^d} \setminus D_\alpha$ for $n \geq k$. But then the functionals C and C_α coincide on $\{\rho\} \cup \{\rho_n\}_{n \geq k}$ and the thesis follows from the continuity of C_α . \square

Remark 3.10. Under the hypothesis (3.4) on ϕ we may propose the following alternative proof for Theorem 3.9 above. Since the pointwise cost c is lower semicontinuous, by the dual formulation (1.2) the functional C is lower semicontinuous too. Then we only need to prove the inequality $\limsup_{n \rightarrow \infty} C(\rho_n) \leq C(\rho)$. By Theorems 3.4 and 3.6 and Lemma 3.8 above, there exists a constant K and an integer ν such that for $n \geq \nu$ we can choose a Kantorovich potential u_n for ρ_n and the cost C which is K -Lipschitz and bounded by K . Up to subsequences we may assume that $u_n \rightarrow u$ uniformly on compact sets, so u is K -Lipschitz and satisfies

$$u(x_1) + \cdots + u(x_N) \leq c(x_1, \dots, x_N).$$

It follows that

$$N \int u d\rho \leq C(\rho) \leq \lim_{n \rightarrow \infty} C(\rho_n) = \lim_{n \rightarrow \infty} N \int u_n d\rho_n = N \int u d\rho$$

as required.

Theorem 3.11. *Let $\rho_1, \rho_2 \in \mathcal{P}(\mathbb{R}^3)$ be such that*

$$\mu_{\rho_i}(\beta) < \frac{1}{N(N-1)^2} \quad i = 1, 2,$$

for a suitable $\beta > 0$. Then for every α as in Theorem 2.4 we have

$$|C(\rho_1) - C(\rho_2)| \leq N^2(N-1)^2 \phi\left(\frac{\alpha}{2}\right) \|\rho_1 - \rho_2\|_{L^1}.$$

Proof. Without loss of generality we may assume that $C(\rho_2) \leq C(\rho_1)$. Let u_1 and u_2 be Kantorovich potentials which satisfy the estimate of Theorem 3.4 respectively for ρ_1 and ρ_2 . We have

$$C(\rho_1) - C(\rho_2) = N \int u_1 d\rho_1 - N \int u_2 d\rho_2.$$

By the optimality of u_1 and u_2

$$N \int u_2 d(\rho_1 - \rho_2) \leq N \int u_1 d\rho_1 - N \int u_2 d\rho_2 \leq N \int u_1 d(\rho_1 - \rho_2)$$

and the conclusion now follows by estimate (3.3). \square

Corollary 3.12. *The functional $C(\rho)$ is Lipschitz continuous on any bounded subset of $L^p(\mathbb{R}^d)$ for $p > 1$ and in particular on any bounded subset of the space \mathcal{H} .*
